# Bankruptcy

**Bankruptcy Law** is governed by Title 11 of the United States Code and is primarily a federal practice. It covers a broad array of individual and corporate financial distress and can include representing debtors in insolvency proceedings, safeguarding creditors' rights, as well as complex corporate restructuring. Bankruptcy matters are supervised by, and litigated in, the United States Bankruptcy Courts (part of the District Courts of the United States) under the Federal Rules of Bankruptcy Procedure.
