Numerous tax clinics and premier events like the Western Conference on Tax Exempt Organizations and Tax Policy Colloquium complement the tax curriculum.

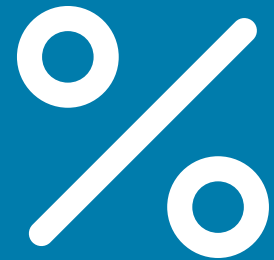
